Kevin Murray motioned to approve the Feb 28^{th} meeting minutes. Jarrod Chambliss 2^{nd} . All approved.

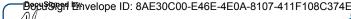
Kevin Murray motioned to approve the both High School Early Graduation and Graduation Policies. Jarrod Chambliss 2nd both. Both all approved.

Ann Marie Taylor introduced our new accounting firm, Veris, who then presented themselves and told us about their services.

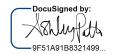
