High School Updates(Governor School, Audits, Performances, Senior Google Site)- Dr. Taylor highlighted a
few things that is going on in the HS department. The Governor school out of Hartsville is partnering with
HCA to offer their Engineering program. Senior Experience-virtual classroom to everything senior related.
Audits of transcripts. Recognized Ashley Sturkie regarding the perfect audit.

Executive Director's Report:

- Board Norms-Board norm document in the Google Drive as to continue norm setting
- Data Overview- School report cards came out last month. Ashleigh Gibbons presented School Accountability
 Updates- HCA outscored ACPSD in ELA and Math for 5th and 6th grade, HCA has increased 8% in ELA for 3-8th grade in SC Ready, HAC has increased 6% in Math for 3-8th grade in SC Ready, Cohort growth in all grades
 for ELA and 2 cohorts in Math for SC Ready and HCA has shown growth in all EOC courses from 2022-2023
 (Alg 1, Eng 2, Biology), HCA report overall- Elementary-Average and Middle School Overall- Average. Full
 report card is on HCA website (hcacs.net).
- Foundation Affiliation Agreement-voting item- Dr. Taylor spoke to the Affiliation Agreement, called Russ, municipal advisor for HCA and the foundation. A Foundation board member present to speak with board-Kerri Knight, member. SPED teacher of 18 years in Kershaw County, Spoke to collective leadership that has been coined at HCA. Jared spoke to how we make this happen, critically, to make it successful as a risk management. Russ spoke to the evolution of HCA and the creation of the HCA Foundation. Russ has been a part of the evolution of HCA over the last several years. Russ spoke to the charter dynamics of SC, he has been doing charter school municipals for the last 25 years, been on charter school boards, legislative boards as well. Russ spoke to how expanding the HCA brand is a good move to put HCA on the offense. HCA is in a position due to the school model and culture that we are able to export what we are doing. Russ spoke to the risk assessment model right now vs the business assessment due to HCA Foundation is unable to control the timing of things happening. Clay Greyson, the Foundation Attorney, is also the attorney of USC affiliates and Clemson affiliates. Treasurer's Report:

- Monthly Updates- Debt ratio and cash on hand slightly dipped from 56 days to 52 days. No real concerns per Jared on behalf of Dana Cook, Treasurer.
- Items over \$7,500 (Voting Item)
 - Outdoor Shed- updated from 26X16 to 32X16, two story still. Justin stated that his only concern is that they are kits and must be assembled and built onsite. Did staff get clarification on permitting anything over 10X10 assembled onsite. Sam asked if it included the assembly cost, no it would does not include the assembly cost. Justin and Jared spoke to the difference of procurements and financial issues with that from a governance standpoint. Extensive discussion was had in regards to procurement and audits. Jared spoke to wanting to know the total cost of the project. Dr. Taylor spoke to using the general contractor and leaning on his knowledge base. Sam spoke with the design of the building and not being crazy about it. Justin spoke with the staff that would be utilizing the second level space. Ashley McCormick asked if it included the shipping cost, Dr. Taylor stated yes. Jared made a motion to approve the item as is, Justin seconded, motion carried. Jared asked that Dr. Taylor and Ashley Sturkie bring the total cost of the project to the next meeting.
- Audit Overview- Ashley called the auditor to give the overview of the audit, Ken. Auditor stated they did
 several audits- state, governmental and federal audits. Completed audit testing and also testing the
 internal controls that safeguard HCA's assets. They found that our safeguards are good, the relationship
 with Vearis has continued to safeguard our assets. No deficiencies found in assets, revenues, and
 expenses. Federal Compliance audit completed- specifically ESSR funds- spending and documented- no
 findings found, or questions raised. It is found of the auditor that the spending and documentation of HCA
 has been fair and compliant.
